5. The bidder should make payment through online receipt towards EMD. No offline receipt of EMD will be allowed in e-procurement portal of Government of Odisha .

The scanned copy of Tender Paper Cost, EMD Deposit, Registrartion Certificate, GST, PAN & affidavit including all required papers uploaded through website and should be produced in original rto the **BDO, BALANGIR** for verification within 3 days of opening of bid.
