

2. The selected quotation must supply required quantity of materials in good condition within 15 days from the date of placing the orders.
3. Delivery of the articles should be made in the Divisional Forest Office, Bolangir Forest Division at their own cost.
4. Damaged Khaki Cloth should be replaced by the party at their own cost.
5. All articles should be supplied as per the sample given and selection thereof, failing which the supply orders will be cancelled automatically.
6. The rate of the articles should be quoted including all taxes.
7. Copy of GST clearance should be accompanied along with the quotations.
8. Payment will be made through Treasury Office after receipt of the articles as per the sample.


