**PROCEEDING OF THE TENDER COMMITTEE MEETING HELD ON DT.18.02.2026 AT 11AM IN
THE OLD CONFERENCE HALL, COLLECTORATE, BALANGIR REGARDING SELECTION OF
MANPOWER SERVICE PROVIDER AGENCY FOR ENGAGEMENT OF PROGRAMME
ASSISTANTS ON OUTSOURCING BASIS IN THE O/O-DSSO, BALANGIR
(Opening of Technical Bids)**

The tender committee meeting for selection of Manpower Service Provider Agency for engagement of Programme Assistants on outsourcing basis in the office of the DSSO, Balangir was held under the chairmanship of the Additional District Magistrate, Balangir at 11AM on Dt.18.02.2026 in the old conference hall of Collectorate, Balangir in presence of the following committee members:

1. Additional District Magistrate -Chairperson
2. District Social Welfare Officer, Balangir -Member
3. CT & GST Officer, Balangir -Member
4. District Social Security Officer, Balangir -Member convenor

A tender call notice bearing no.338/DSSO, Dt.05.02.2026 has been issued for inviting bids for providing manpower on outsourcing basis in the office of the DSSO, Balangir in the post of Programme Assistants (23nos.).

In pursuance to the above tender call notice FIVE (5) nos. of tenders have been received within due timeline, which are placed before the tender committee on Dt.18.02.2026. The bids have opened on the scheduled date and all the documents have been verified by the tender committee members. The following details have been emerged out after careful verification of all the documents submitted by the 5nos. of Bidders.

Sl. NO.	Name & Address of the Bidder	Remarks
1	Royal Security Services, Balangir	All the required documents attached by the bidders, verified & found to be correct.
2	Herald Manpower & Placement Service, Bhubaneswar	All the required documents attached by the bidders, verified & found to be correct.
3	All Services Global, Balangir	All the required documents attached by the bidders verified. On verification, it is found that the EMD of Rs.3,00,000/- submitted by the bidder is of back date and not of current tender period. Further, the PAN card is in the name of owner but not in the name of agency.
4	RNC Security Services, Balangir	All the required documents attached by the bidders verified and it is found that the Labour License attached is invalid. While verifying the same, it is found that the license number is registered in the name of <u>Maa Mangala Construction Pvt. Ltd.</u> And while scanning the QR of the license it is found that it is registered in the name of <u>Sunstar Security Services, Bhubaneswar.</u> Further, the EPF Statement showing deposit of EPF is also found to be invalid. While scanning QR Code of the EPF Statement it is showing same TRN number in all EPF Statements. Again, there is no agreement copy of the previous tenders as per the required documents list as mention in the tender call notice.
5	PRATYUSH, Bhubaneswar	All the required documents attached by the bidders, verified & found to be correct.

After careful observation and verification of documents of all the bidders (5nos. of bidders) by the tender committee members, the following bidders have not qualified in Technical Bid and found to be ineligible for Financial Bid.


1. All Services Global, Balangir (Sl. No. 3)
2. RNC Security Services, Balangir (Sl. No. 4).

Further, the following 3 nos. of bidders have qualified in the Technical Bid and found to be eligible for Financial Bid.

1. Royal Security Services, Balangir
2. Herald Manpower & Placement Service, Bhubaneswar
3. PRATYUSH, Bhubaneswar
