Sealed Quotation are hereby invited from registered, experienced and eligible transporters / agencies/ Owner for transportation of Non-recyclable waste, i.e. Refuse Derived Fuel (RDF) / Plastic Waste from Balangir Municipality to cement plants for co-processing, using 14-16 Ton capacity covered trucks, as per the terms and conditions detailed below.

1. Name of the Work: Transportation of Refuse Derived Fuel (RDF) / Plastic Waste from Balangir Municipality to Cement Plants.

2. Scope of Work: The work includes:

- a. Deployment of **14–16 MT capacity covered trucks**
- b. Loading of RDF / Plastic Waste at designated site of Balangir Municipality
- c. Safe transportation to the designated cement plant
- d. Unloading at destination
- e. Compliance with all applicable safety, environmental and statutory norms
- f. Agency Registration Certificate, PAN, Valid documents Vehicle

3. Source Location: Material Recovery Facility (MRF) / designated storage point under Balangir Municipality.

4. Destination: Transportation shall be carried out to either of the following destinations, as decided by Balangir Municipality from time to time:

1. **Dalmia Cement Factory, Rajgangpur, Sundargarh District, Odisha**
2. **Ambuja Cements (Adani Group) Plant, Bhatapara, Chhattisgarh**

5. Vehicle Requirement


