OBJECTIVES AND SCOPE OF THE SOCIO-ECONOMIC SURVEY.

The Upper Lanth Irrigation Project is a medium irrigation project over the river 'Lanth a tributary of river **'Tel'**. The proposed dam of the project will be established near the villages of Chikhili in Belpada block of Balangir district, which is nearby 20 kms. Distance from Belpada Block & 80 KM from District headquarter Balangir.

In this project, 7 villages will be affected of which 2 villages will be fully submerged and 5 villages will be partly submerged.

Land Acquisition has been started in 7 villages as per RFCTLAR&R Act, 2013. All the 7 affected villages of the project are coming under the administrative jurisdiction of 2 Blocks namely, Belpada and Khaprakhol.

Notification U/s. 11(1) has already been published in respect of 7 nos of above villages. The selected Agency shall start Survey & Census work in this village immediately after executing the agreement with the authority and complete it within 50 days from the date of execution of agreement.

Part – A. SOCIO ECONOMIC SURVEY OF SUBMERGED/ AFFECTED VILLAGES UNDER UPPER LANTH IRRIGATION PROJECT, BELPADA, BALANGIR

To identify total number of Project Affected / Displaced Families, Livelihood Loser & Landless as per Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (RFCTLARR Act 2013) in the villages coming under Upper Lanth Irrigation Project, Belpada, Balangir.

- i. The survey must cover all the Household of 2 villages.
- ii. The survey & census shall commence simultaneously in the Notified villages.
- iii. The census & survey field team will be responsible for collection of all relevant data photographs, documentation, compilation and report preparation. All the task shall be completed within the stipulated period of time 90 days (*60 days for collection of relevant data, photographs, documents etc. for census & survey and next 30 days for compilation of data and submission of final report*).
- iv. The successful bidder should be able to engage adequate number of field staff and other officers in order to complete the survey, census report in all the selected villages simultaneously.
- v. Whose land or other immovable property is being acquired.
- vi. Members of those families which are without homestead land and which has been residing in the project affected area continuously for a period of not less than three (03) years preceding the date of notification of the projects.
- vii. Persons who do not own any land in the project affected area but derive their income from working in the project area from three years prior to the acquisition of the land like agricultural laborers, tenants, sharecroppers, gatherers of forest produces, fisher communities, etc.
- viii. Entitled land holding families under forest right act, 2006 whose land is within project boundary.
- ix. Persons who have been allotted land by state government or central government under any of their schemes and such land are under acquisition.
- x. Persons who have been allotted land by judicial orders and such land is under acquisition.
- xi. To classify different categories of Project Affected Families (PAFs) on the basis of demographic data.
- xii. To identify village wise list of project affected persons (along with names of their family members) for all project affected villages, belong to schedule caste and schedule tribe category as per guidelines of Odisha Government.
- xiii. To identify village wise list of physically handicapped / *divyang* persons, vulnerable persons, minor orphans with name of guardians and deserted women in the project affected villages.

- xiv. To find out the impact of the projects on public and community properties, assets and infrastructure particularly roads, public transport, drainage, sanitation, source of drinking water, source of water for cattle, ponds, grazing land, plantations, public utilities such as Post Offices, Fair Price Shops, Food Storage, Go Downs, Electricity Supply, Health Care Facilities, Schools, Educational or Training Facilities, Anganwadis, Children Park, Places of Worship, Land for Traditional Tribal Institutions and Burial and Cremation Grounds.
- xv. To take stock of all resources including the CPRs (common property resources) village wise and their uses in the existing villages and to make an assessment of the opportunity loss. To list out the extent of CPRs to be affected by the projects.
- xvi. To determine the ownership over land holding, present land use pattern and the extent of loss of land (government and private land) due to the setting up of the project. Also to estimate the household's loss of production due to land acquisition.
- xvii. To ascertain varieties of loss suffered by Project Displaced Families (PDFs) and Project Affected Families (PAFs).
- xviii. To ascertain choices of affected families with reference to various options and provide baseline data for preparation of **R&R plan** in consultation with the Displaced Families / Affected Family concerned.
- xix. The provisions of RFCTLA & RR Act, 2013 has to be followed in the preparation of the R&R Plan and Entitlement Matrix.

Part – B PREPARATION OF SOCIO ECONOMIC SURVEY REPORT AND ENTITLEMENT MATRIX:

- x. Resettlement option by the Displaced Families.
- xi. All supporting documents like copy of patta, L.A. Notice if any, age supporting documents for 18+ sons (Voter list, Photo Parichaya Patra, School Leaving Certificate, copy of ANM Register of village). Genealogy (Yadast Registrar or certified genealogy of Special L.A & R. O).
- xii. Option form for land or cash to be attached to each individual survey format.
- xiii. Any other condition as enshrined in the R&R Policy- 2006 & other concerned departments of the Government of Odisha, not enumerated above but relevant to the project work shall be adopted with discussion & approval of appropriate authority.
- xiv. All the individual survey formats, all the proofs as in point 11 above, the survey report of each village (both in hard copy & soft copy) have to be submitted to the Project Director (R&R), within the time period of the contract / agreement.

The intending bidder must possess the requisite experience, resources and capability in providing the services necessary to meet the requirements as described in the scope of work. The bidder must also possess the technical know-how and the financial wherewithal that would be required for successfully providing services sought by the Special LA & RO, Upper Lanth Irrigation Project, Belpada, Balangir for the entire period of the contract. To qualify the technical evaluation state, the bidder must score a minimum of 70 marks out of 100.

1. **Special LA & RO, Upper Lanth Irrigation Project, Belpada**, Balangir will open the Financial Bids of those Bidders who will achieve minimum score of 70 marks in technical evaluation.
2. Documentary evidence (Citation, copy of completion / Ongoing Client Certificate and Work Order / Contract) is required for all project experience.
3. Special LA & RO, Upper Lanth Irrigation Project, Belpada, Balangir (or a nominated party) reserves the right to check / validate the authenticity of the information provided by the Bidder for Technical Evaluation criteria and the requisite support must be provided by the Bidder.
4. The bidder should come prepared for technical presentation which is allowed maximum period of 10 minutes. In the technical presentation the bidder should show the performance of institution, success stories, approach, methodology through power point presentation & videos. The PPT and video should be in soft copies and handed over to the Special LA & RO, Upper Lanth Irrigation Project, Belpada, Balangir.

Financial Evaluation

In the second state, the financial evaluation will be carried out as per this Clause. Each Financial Proposal will be assigned to financial score (**S_F**). For financial evaluation, the total cost indicated in the Financial Proposal and illustration.

The Special LA & RO, Upper Lanth Irrigation Project, Belpada, Balangir will determine whether the Financial Proposals are complete and unconditional. The cost indicated in the financial proposal shall be deemed as final and reflecting the total cost of services. Omissions, if any, in costing any item shall not entitle the firm to be compensated and the liability to fulfill its obligations as per the ToR Financial Proposal (**F_M**) will be given a financial score (**S_F**) of 100 points. The financial scores of other proposals will be computed as follows:

$$S_F = 100 \times F_M / F$$

(F = Amount of Financial Proposal under consideration).

Provided that the Bid is substantially responsive, the Authority shall correct arithmetical errors on the following basis:

If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Employer there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;

- If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail.

Any conditional Bids shall be summarily rejected.

Quality Cost Based System(QCBS) of Evaluation of Technical & Financial Bid

- **The minimum qualifying Technical score is: 70**
- **Evaluation of Technical and Financial Score**
- The formula for determining the technical score is as follows:-
- $St = (100 \times T / Th)$, in which St is the normalized technical score, Th is the highest technical score and T is the technical score of the proposal under consideration.
- The formula for determining the financial scores is as follows:-
- $Sf = 100 \times FI / F$, in which Sf is the financial score, FI is the lowest price and F the price of the proposal under consideration.
- The weights given to the Technical and Financial Proposals are:

Right to terminate the process

The selected bidder commits a breach of any of the terms and conditions of the bid. The bidder goes into liquidation, voluntarily or otherwise.

An attachment is levied or continues to be levied for a period of seven days upon effects of the bid.

If the selected bidder fails to complete the assignment as per the time lines prescribed in the Bid and the extension if any allowed, it will be a breach of contract. The Spl LA & RO, Upper Lanth Irrigation Project, Belpada reserves its right to cancel the order in the event of delay and forfeit the bid security as liquidated damages for the delay.

No assignment

Survival
